1. Area of application of your GARDENA AccuJet 18-Li**Proper use as blower:**

The GARDENA AccuJet 18-Li is suitable when used as a blower for sweeping debris or grass clippings from driveways, sidewalks, patios, etc. and for blowing grass clippings, straw, or leaves into piles, or removing debris from corners, around joints, or between bricks.

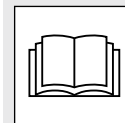
If not used properly this product can be dangerous. The warnings and safety instructions must be followed to ensure reasonable safety and efficiency in using this product. The operator is responsible for following the warnings and instructions in this manual and on the product. Never use the product unless the guards provided by the manufacturer are in the correct position.

2. Safety instructions

→ Please note the safety instructions on the AccuJet 18-Li.



WARNING: This unit can be dangerous! Careless or improper use can cause serious injury.



Read the user instructions carefully to make sure you understand all of the controls and what they do.



Do not expose to rain. Do not leave the product outdoors while it is raining.



Remove battery before cleaning or performing maintenance.



The use of eye and ear protection is recommended.



Keep bystanders away.

General Power Tool Safety Warnings

WARNING: Read all safety warnings and all instructions. Failure to follow the warnings and instructions may result in electric shock, fire and/or serious injury.

Save all warning and instructions for future reference.

The term "power tool" in the warnings refers to your battery operated (cordless) power tool.

1) Work area safety

a) This product is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning the use of the product by a person responsible for their safety. Children should be supervised to ensure that they do not play with the product. Local regulations may restrict the age of the operator. Never allow children or people unfamiliar with these instructions to use the product.

Power tools are dangerous in the hands of untrained users.

b) Never operate the product while people, especially children, or pets are nearby. Distractions can cause you to lose control.

c) Never blow debris in the direction of bystanders.

The operator or user is responsible for accidents or hazards occurring to other people or their property.

d) Keep work area clean and well lit. Cluttered or dark areas invite accidents.

e) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.

2) Electrical safety

a) Power tool plugs must match the outlet. Never modify the charger plug in any way. Do not use any adaptor plugs with earthed (grounded) power tools. Use only on AC mains supply voltage shown on the product rating label. Unmodified plugs and matching outlets will reduce risk of electric shock.

b) Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators.

There is an increased risk of electric shock if your body is earthed or grounded.

c) Do not expose power tools to rain or wet conditions. Water entering a power tool will increase the risk electric shock.

d) Do not abuse the charger or charger cord. Never use the charger cord for carrying, pulling or unplugging the charger. Keep charger and charger cord away from heat, oil, sharp edges or moving parts. Before use, examine for damage. Replace charger and/or charger cord if there are signs of damage or aging. Do not use the product if the charger or charger cord is damaged or worn. Immediately disconnect from the mains electricity supply if the cord is cut, or the insulation is damaged. Do not touch the electric cord until the electrical supply has been disconnected. Do not repair a cut or damaged cord. Replace it with a new one. Damaged or entangled cords increase the risk of electric shock.

e) The electric cord must be uncoiled.

Coiled cord can overheat and reduce the efficiency of the product. Always wind cord carefully, avoiding kinks.

f) Only use the charger provided with your unit when charging the battery.

Use of any other charger could permanently damage the battery, charger and/or the blower unit.

g) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply with a tripping current of not more than 30 mA. Even with a RCD installed, 100% safety cannot be guaranteed and safe working practices must be followed at all times. Check your RCD every time you use your product.

Use of an RCD reduces the risk of electric shock.

3) Personal safety

a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication.

A moment of inattention while operating power tools may result in serious personal injury.

b) Use personal protective equipment. Always wear eye protection and hearing protection. To prevent dust irritation, the use of a dust mask is recommended.

Protective equipment such as eye protection, hearing protection, dust mask, nonskid safety shoes, or hard hat used for appropriate conditions will reduce personal injuries.

c) Prevent unintentional starting.

Battery-powered units do not have to be plugged into an electrical outlet to operate; therefore, they are always in operating mode. Ensure the switch is in the off position before connecting to battery charger, picking up or carrying the tool.

Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.

d) Do not overreach. Keep proper footing and balance at all times. On slopes, be extra careful and wear non-slip footwear. Do not walk backwards while operating your product. Walk, never run. Do not use ladders while operating the product.

This enables better control of the power tool in unexpected situations.

e) Dress properly. Always wear suitable clothing, gloves, and stout shoes.

Do not wear loose clothing or jewellery. Keep your hair, clothing and gloves away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.

4) Power tool use and care

a) Only use the product in the manner and for the functions described in these instructions. Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.

b) Always make sure your product is in a safe operating condition before use. Do not use the power tool if the switch does not turn it on and off. Know how to stop the product quickly in an emergency. Any power tool that cannot be controlled with the switch is dangerous and must be repaired.

c) The impeller continues to rotate after your product has been switched off.

The motor must be stopped and the impeller blade no longer turning to avoid serious injury from the rotating blades.

d) Remove battery from unit:

- before leaving the product unattended for any period;
- before clearing a blockage;
- before checking, cleaning or working on the appliance;
- if the product starts to vibrate abnormally. Check immediately. Excessive vibration can cause injury.
- before passing to another person.

e) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool. Power tools are dangerous in the hands of untrained users.

f) Maintain power tools. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Keep all cooling air inlets clear of debris.

Many accidents are caused by poorly maintained power tools.

g) Use the power tool and accessories in accordance with these instructions, taking into account the working conditions and the work to be performed. Use the product only in daylight or good artificial light. Use of the power tool for operations different from those intended could result in a hazardous situation.

5) Battery tool use and care

a) Recharge only with the charger provided with your unit and specified by the manufacturer.

A charger that is suitable for one type of battery may create a risk of fire when used with another battery.

b) Use power tools only with specifically designated batteries.

Use of any other batteries may create a risk of injury and fire.

c) When battery is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another.

Shorting the battery terminals together may cause burns or a fire.

d) Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery may cause irritation or burns.

6) Maintenance and storage

Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.

- Keep all nuts, bolts and screws tight to be sure the product is in a safe working condition.
- Replace worn or damaged parts for safety.
- Use only genuine replacement parts and accessories.
- Store in a cool dry place and out of reach of children. Do not store outdoors. The unit must not be stored over 35 °C or under direct exposure to sunlight. Do not store the unit in places with static electricity.

Blower safety warnings

• Inspect the area before using the unit.

Remove all debris and hard objects such as rocks, glass, wire, etc., that can ricochet, be thrown, or otherwise cause injury or damage during operation.

• Never run the unit without the proper equipment attached.

When used as a blower, always install a blower tube. Use only recommended attachments to prevent personal injury.

• Do not use blower near leaf or brush fires, fireplaces, barbecue pits, ashtrays, etc.

Proper use of the blower will help avoid spreading fire.

• Never place objects inside the blower tubes; always direct the blowing debris away from people, animals, glass, and solid objects such as trees, automobiles, walls, etc.

The force of air can cause rocks, dirt, or sticks to be thrown or to ricochet which can hurt people or animals, break glass, or cause other damage.

• Never use for spreading chemicals, fertilizers, or any other substances. This will prevent the spreading of toxic materials.

Battery safety



FIRE RISK!

→ Never charge the batteries near acids or easily inflammable materials.



RISK OF EXPLOSION!

→ Protect blower unit from heat and fire. Do not leave on radiators or expose to strong sunshine for long periods.



Do not use the battery charger outdoors.

→ Protect the battery charger from damp or wet areas.

Only use your unit in an ambient temperature between -10 °C and +45 °C.

The charging cable should be checked regularly for signs of damage or ageing (brittleness) and may only be used if it is in perfect condition. The charger provided may only be used to charge the rechargeable batteries supplied with this unit.

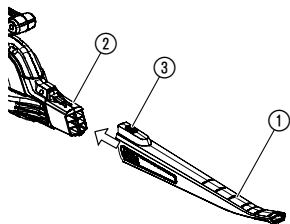
Non-rechargeable batteries must not be charged with this battery charger (danger of fire).

The unit must not be operated during charging. After charging, disconnect the charger from the mains.

Only charge battery between 10 °C – 45 °C. After heavy duty service allow battery to cool down first.

3. Assembly

Fitting the blower tube:



WARNING: Stop the unit and remove battery before attempting to install or remove the blower tube. The motor must be stopped and the impeller blades no longer turning to avoid serious injury from the rotating blades.

1. Align the grooves on the blower tube ① with the grooves on the blower outlet ②.
2. Push the blower tube onto the blower outlet until it snaps into place; tube is secured to blower by tube release button ③.
3. To remove the blower tube, press the tube release button ③ while pulling on tube.

4. Initial Operation

Charging the battery:



WARNING: Overvoltage damages batteries and the battery charger.
Ensure the correct mains voltage.

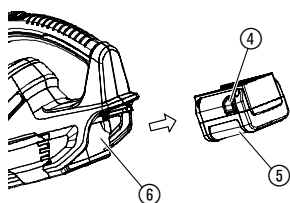
Before using for the first time, the battery must be fully charged. Charging time (for uncharged battery) see 9. Technical Data.

When charging the battery, only use the GARDENA charger, art. no. 8840-00.630.00, included with your unit.

The lithium-ion battery can be charged in any state of charge, and the charging process can be interrupted at any time without harming the battery (no memory effect).

So that the fully charged battery is not discharged, the battery should be disconnected from the battery charger.

1. Press the locking buttons ④ in and remove the battery ⑤ from the handle ⑥.
2. Plug the plug of the charger cable ⑦ into the battery ⑤.
3. Plug battery charger ⑧ into a mains socket.



Charging indicator lamp lights up red:
The battery is being charged.

Charging indicator lamp lights up green:
The battery is fully charged.
(For charging time, see 9. Technical Data)

4. First disconnect the plug of the charging cable from the battery and then unplug the battery charger from the mains socket.
5. Push the battery from bottom onto the handle.

Avoid exhaustive discharge:

Do not wait until the blower comes to an absolute stop (battery totally discharged) as this shortens the battery life. If the output of the blower decreases noticeably, charge the battery.

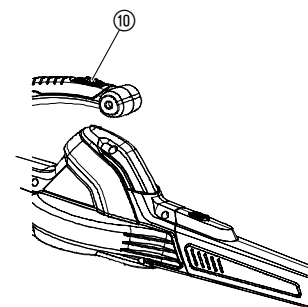
If the battery has been totally discharged, the LED will flash at the start of charging. If the LED is still flashing after an hour, a fault has occurred (see 8. Troubleshooting).

5. Operation



WARNING: Do not use the unit without the tube properly attached to avoid flying debris and/or impeller contact which can cause serious injury.
Always wear gloves and use eye protection to prevent rocks or debris from being blown or ricocheting into the eyes and face which can result in blindness or serious injury.

Starting the blower:

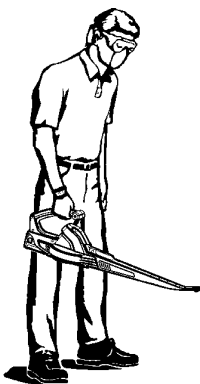


Switching the blower on:

1. Push the battery onto the handle (see 4. Initial Operation).
2. Move the ON/OFF switch ⑩ to the ON (I) position.

Switching the blower off:

1. Move the ON/OFF switch ⑩ to the OFF (0) position.
2. Remove the battery from the handle (see 4. Initial Operation).

Working positions:

Use your unit as a blower for sweeping debris or grass clippings from driveways, sidewalks, patios, etc. Also, for blowing grass clippings, straw, or leaves into piles, or removing debris from corners, around joints, or between bricks.

Direct air flow by directing the blower tube down or to one side.

Always work away from solid objects such as walls, large stones, vehicles, and fences.

Clean corners by starting in corners and moving outward. This will help prevent an accumulation of debris which could fly into your face. Be careful when working near plants. The force of the air could damage tender plants.

6. Storage

Storage:

Store unit with battery removed, well out of the reach of children.

1. Stop unit and remove battery (see 4. Initial Operation).
2. Charge battery; this will increase the life of the battery.
3. Allow motor to cool before storing or transporting.
4. Store unit with all guards in place. Position unit so that any sharp object cannot accidentally cause injury.

Extended storage:

Prepare unit for storage at the end of the season or if it will not be used for 30 days or more.

If your blower is to be stored for a period of time:

1. Stop unit and remove battery (see 4. Initial Operation).
2. Charge battery; this will increase the life of the battery.
3. Clean the entire unit before lengthy storage.
4. Use a soft brush to clean air vents and air inlet of debris. Do not use water.
5. Store your unit in a well ventilated area and covered, if possible, to prevent dust and dirt accumulation. Do not cover with plastic. Plastic cannot breathe and may cause condensation and eventual rust or corrosion.
6. Check entire unit for loose screws. Replace any damaged, worn, or broken parts.
7. Remove blower tube for easier storage.

7. Maintenance



WARNING: Always stop the unit and remove the battery before making any adjustments, changing accessories, or performing maintenance (see 4. Initial Operation).

Such preventive safety measures reduce the risk of starting the power tool accidentally.

BEFORE EACH USE**Check for loose fasteners and parts:**

Keep all nuts, bolts and screws tight to be sure the product is in a safe working condition. Be sure all parts are assembled properly.

- Blower Tube

Check for damaged or worn parts:

Contact your authorized service dealer for replacement of damaged or worn parts.

- ON/OFF Switch – Ensure switch functions properly by moving the switch to the OFF position. Make sure motor stops; then restart motor and continue.

AFTER EACH USE**Inspect and clean unit and labels:**

- After each use, inspect complete unit for loose or damaged parts. Clean the unit using a damp cloth.
- Wipe off unit with a clean dry cloth.

8. Troubleshooting



WARNING: Always stop unit and remove the battery before performing all of the recommended remedies below except remedies that require unit to be operating (see 4. Initial Operation).

The motor must be stopped and the impeller blades no longer turning to avoid serious injury from the rotating blades.
